Motion by Hill to approve the agenda as presented. Seconded by Shipley. Motion carried unanimously.

Motion by Shipley to approve the September 18 annual and organizational meetings and the October 2 work session as presented. Seconded by Hill. Motion carried unanimously.

Updates/Information

- A. Legislative Advocacy Phil Jenery (IASB) talked about the upcoming legislative session in regards to the statewide penny. Extending the statewide penny would provide more resources for infrastructure projects. Extending the statewide penny past 2029 is more urgent among urban legislators rather than rural as the infrastructure need is greater. The extension is important to Carlisle as the District has a low property tax base and needs the additional funds that would be generated through an extension to fund additional projects. Possible projects (providing the proper funding) are elementary windows and high school gym and learning environment. The governor seems to be supportive of the extension but it is speculated that the extension past 2029 would have some stipulations. We need to get the legislators involved and into the buildings. Also the District needs to get involved in advocating for a statewide penny clean extension. Mr. Jenery noted that the advocacy section on the IASB website would be a good resource.
- B. ACT Progress Monitoring Report The ACT scores averaged a decrease of 2.1 which was expected because of the increase in the number of students testing. Twenty percent of the students met all four benchmark indicators. Carlisle did outpace both the state and national percentages of graduates taking the ACT. The next steps will be to analyze the ACT data and develop strategies for the next level of work to prepare for the administration of the ACT to all juniors in the Spring, 2018.
- C. Review of School Board Goals for Superintendent Mr. Amos reviewed the school board's goals set for him along with the District's goals and the Vision 2020 long range goals. A District report card will be ready in December.
- D. High School Construction Update The sprinkler system is 100% up and running but not yet certified because of the choir and band rooms. The HVAC is 90% balanced. The choir and band rooms are on schedule (late October and early November respectively). The Wildcat Way road is behind schedule. There will be a tour of the high school before the next work session,
