President Hill called to order the September 14 regular school board meeting at 6:00 p.m.

Motion by Shipley to approve the agenda. Seconded by Fett. Motion carried unanimously.

Motion by Eginoire to approve the August 10 regular meeting and August 31 special meeting minutes as presented. Seconded by Donovan. Motion carried unanimously.

UPDATES/INFORMATION

- A. CHS Homecoming Event Schedule Mr. Amos reviewed the Homecoming week schedule. Homecoming week is September 28 – October 2. Monday through Friday will be dress up days. Thursday will be the coronation at 7:30 at the football field weather permitting (otherwise in the Wildcat Activity Center). There is a cost of \$5.00/ticket. The event will be live streamed. The pep rally is Friday at 2:15 for high school students only. It will be held at the football field or the Wildcat Activity Center, depending on the weather. It will also be live streamed. There will not be a pep rally at each of the other buildings this year. There will not be a Homecoming parade. The dance will be postponed to hopefully have it at a later date. The week will end with the football game Friday night.
- B. Return to School Planning (District Return to School Site)
 - i. Current Cases Mr. Amos will be posting on the District's website, www.carlislecsd.org, every Friday updates on the number of COVID -19 cases in school, the number in guarantine and the positivity rate. For the week ending September 11 there was 1 confirmed student case and 4 confirmed staff cases. There were 58 students in quarantine and 4 staff. The positivity rate for Warren County was 7.4 and 7.9 for Polk County.
 - ii. Notification Flow Chart Mr. Amos reviewed the notification protocols if there is a positive

COVID-19 case in any of the schools. The principals or supervisor would be the first contact. Warren County Health is then notified and will give contract tracing guidance. The District office will also be notified and contract tracing will begin. The quarantine list is sent to Warren County Health for their review and approval. Notifications are then sent to parents/guardians and a notice is put on the District's website as well. The District's database will be updated. The Warren County Superintendents meet with Warren County Health weekly.

- iii. Federal Lunch Program Reinstated USDA extended the summer food feeding program which is allowing all K-12 students to receive a free breakfast and lunch every day. This started September 14 and will run through December 31 or until the money runs out.
- C. School Community Focus Groups Racial Equity Community Forums Mr. Amos held the first forum with 33 patrons having signed up and 12 attending the zoom meeting. There were good conversations and it opened the door. It was a chance to listen and gain understanding. A second forum is scheduled for September 15 with 25 people signed up to date. After the Tuesday meeting, the feedback will be reviewed and ideas discussed on how or where the District can make the most difference. Professional development for all staff, parent education and curriculum review are several areas that will be addressed. Mr. Amos thanked the participants.
- D. Board Policy Review Series 100 & 200 (Board review of recommendations at October Board meeting) Board Policy needs to be reviewed every 5 years. This fall, series 100, 200 and 300 will be reviewed. Series 100 and 200 will be reviewed at the October board meeting. The board policy committee will meet prior to the board meeting. Mr. Shipley and Mrs. Fett are the school board representatives on the committee. The committee will review the board policy to make sure policy meets practice and practice meets policy. Their recommendations will be presented at the October board meeting.
- E. District Enrollment Update During the second week in September, the District enrollment was 2,306, up 31 students as compared to this time last year. This number reflects the number of students attending school at Carlisle. The official state enrollment count is taken October 1 which records the number of resident students.

BUSINESS/ACTION ITEMS

A. Approval of Updates District Return to School Plan

Motion by Shipley to approve the updates to the District Return to School Plan as presented. Seconded by Eginoire. Motion carried unanimously.

B. Approval of Purchase Amount of \$152,000 for 200 School Street Property

The owner and the District agreed on a purchase price of \$152,000. There is no timeline yet for the transaction. The District will purchase the property for a future project.

Motion by Eginoire to approve the purchase amount of \$152,000 for the 200 School Street property. Seconded by Fett. Motion carried unanimously.

C. Approval of Amendment to the High School Swimming Sharing Agreement

Currently the District has a sharing agreement with Des Moines Lincoln, along with Norwalk, for students to participate in swimming. Carlisle has 5 students participating. Since Des Moines cannot participate in extracurricular activities with remote learning, Norwalk has initiated a new agreement, with Norwalk being the host school. There will be no home events as they can't swim at Lincoln. The Districts are working with the athletic associations to determine a coach. There will be some additional costs with the new agreement. The families involved have been contacted. Should Des Moines be able to participate in extracurricular activities, we will go back to the original agreement.

Motion by Eginoire to approve the amendment to the high school swimming sharing agreement as
