UPDATES/INFORMATION

- A. Updates to School Reopening Plans
 - Critical Personnel Procedures
 - Positive Case Notification Procedures

Mr. Amos presented updates to the school reopening plans. The state allows schools to bring back critical personnel if there are shortages in staff if they have no symptoms and are fever free. This only pertains to staff who are quarantined for close contact. If staff have tested positive, they would have to stay out the full quarantine period. In order to come back, staff would have to have 10 days of no symptoms as documented with staff member's supervisor and 2 negative COVID-19 tests and/or alternative diagnosis by health care provider. Staff returning prior to the 14 day period would have to wear a face covering at all times (except to eat or drink), maintain physical distance at all times, all breaks done in isolation and a health screening prior to coming to work/during mid-day/after work. The District will let parents know if this situation arises. Warren County Health has reviewed the procedures.

Those determined to have had close contact with a COVID-19 positive individual will be notified directly by school personnel. They will have to quarantine for 14 days. When it is a student, the student's family will receive a phone call from a school staff member. If contact is not deemed close contact, they will receive personal notification. Families of students will be contacted to let them know of the positive case. They will not be automatically be excluded from school but should be closely monitored for 14 days for symptoms.
