#### **UPDATES/INFORMATION**

D. K-12 Summer Program Updates – The District will be expanding summer programming in all four buildings to address student learning loss which will be funded with At-risk/DOP and ESSER II funds. The four focus areas are: provide academic intervention/support in the core academic areas, social and emotional learning supports, grade level transition support and high school credit recovery. Transportation and food services will be provided for all buildings except for the high school. The programming will run 4 days a week for a half day in all buildings except for the high school. Summer school will be 3 days a week (Tuesday-Thursday). The dates of the summer program for Carlisle elementary school are June 9-24, 8:00 – Noon. The dates at Hartford are July 19 – August 5 from 9:00 – noon. For the middle school, the dates are July 19 – August 5 and for the high school June 8 – July 1 from 9:00 – 1:00. - E. Open Enrollment Grade Level Limits for 2021-22 School Year The District was notified on April 6 that Des Moines will approve all open enrollment applications out from Des Moines to Carlisle which is not typical. Mr. Amos reviewed the number of open enrollment in-to-district applications for 2021-2022 and enrollment projections. He also reviewed procedures as a receiving district and the reasons applications can be denied. The District has until June 1 to make a decision on the applications. Mr. Amos will be discussing with the principals the projected class sizes for next school year and potential impact of the open enrollment applications in to Carlisle. He will bring back proposed procedures for open enrollment for 2021-2022 applications at the May 10 school board meeting.
- F. Return to School Updates
  - a. District Metrics The numbers continue to stay pretty steady. There have been a couple of recent student positives but no quarantines because of mask wearing. The number of remote students for the fourth quarter is 284 with 2020 on site (88%).
  - b. ESSER II & III Funding The District has received and will receive federal funding as a result of the pandemic to help schools safely open, sustain safe operation of schools and address the impact of the pandemic on students. The District's numbers are: ESSER I = \$119,521, ESSER II = \$566,007, ESSER III = 1,271,172 and GEER I = 71,600. These funds are one-time funds and will be received as a reimbursement. District leadership will be looking at ways to spend the funds.

#### **PUBLIC HEARINGS**

G. 2020-2021 Budget Amendment

The 2020-2021 budget amendment hearing started at 7:01 p.m. The budget is being amended in three of the four function areas: instruction – increase of 129,100 (early retirement plan, tech & furniture purchases), total support services – increase if 577,400 (coding changes, insurance increase) and noninstructional programs – increase of 100,000 (building trades & C-store expenditures increase). No public comments received. The public hearing ended at 7:03 p.m.

#### H. 2021-2022 Budget

The public hearing for the 2021-2022 budget began at 7:03 p.m. The District is proposing a tax levy of 17.81317. It is made up of the general fund levy of 11.13557 (\$4,660,284), management levy of .95760 (\$400,000), PPEL levy of 1.67 (\$7,071,153) and debt service levy of 4.05 (\$1,714,951). State supplemental aid increased 2.4% plus an additional \$10 for a district cost per pupil at \$7,227 which will generate \$15,684,989 in state aid based on enrollment. The budget was published April 1 and will be taken to the county auditor and sent to the Dept. of Management to meet the April 15 deadline. No public comments were received. The public hearing ended at 7:20 p.m.

#### **BUSINESS/ACTION ITEMS.**

A. Board Action on the 2020-2021 Budget Amendment

Motion by Eginoire to approve the 2020-2021 budget amendment as presented. Seconded by Fett. Motion carried unanimously.

B. Resolution levying a tax for Fiscal Year 2021-2022 for the future optional redemption of General Obligation School Building Bonds, Series 2018

The resolution is for the proposed debt surplus levy in the amount of \$235,000 to pay on the series 2018 bonds when they become callable.

Motion by Eginoire to approve the resolution levying a tax for fiscal year 2021-2022 for the future optional redemption of general obligation school building bonds, series 2018. Seconded by Fett. Motion carried

#### E. 2020-2021 Updated School Calendar

The District has to make up 9½ instructional hours. This will be done by going all day every day the last week of school, May 24-28. There will be no early dismissals that week. The last day of school for grades PS – 11 will be May 28. The last day for teachers is June 2. This information has been included in the Wildcat Weekly to inform parents.

Motion by Gardner to approve the 2020-2021 updated school calendar. Seconded by Fett. Motion carried unanimously.

## F. Board Policy Review of 505.6

The proposed changes are to allow students more flexibility in scheduling and reflect practice. Motion by Donovan to approve the changes to board policy 505.6. Seconded by Fett. Motion carried unanimously.

# G. Open Enrollment Grade Level Limits for 2021-22 School Year

Motion by Eginoire to table action on the open enrollment grade level limits for 2021-22. Seconded by Gardner. Motion carried unanimously.

## H. AEA Purchasing Agreement 2021-2022

The agreement is for purchasing of food, small wares, and ware wash for the nutrition department for the 2021-2022 school year.

Motion by Fett to approve the AEA purchasing agreement for 2021-2022 as presented. Seconded by Donovan. Motion carried unanimously.

#### I. William Scotsman Amendment to Lease Agreement

The agreement is to extend the lease agreement for the portable at Hartford for another two years. Motion by Eginoire to approve the Williams Scotsman amendment to lease agreement as presented. Seconded by Fett. Motion carried unanimously.

# J. Resolution 0421-001, Approving Sale of Real Property
