UPDATES/INFORMATION

- A. PLC Model District Bryce Amos, Solution Tree State of Iowa Executive Director, presented the Board with Carlisle's PLC Model District recognition. Only 25 school districts in the state have this recognition. Mr. Anderson thanked the dedication of the teachers.
- B. 7th Grade Baseball Mr. Anderson informed the board that we were unable to hire a 7th grade baseball coach. The district will be informing students and parents that the district will not be offering 7th grade baseball this year.
- C. School Safety The focus will be on adding an additional SRO and a hallway monitor in each secondary building. The district is also looking at options for an in-school PK-5 therapy program.
- D. Enrollment Caps 24-25 The board agreed with the 2024-25 enrollment caps as presented by Mr. Anderson.
- E. Open Enrollment Transportation Mr. Anderson informed the board that we are going to stay with the current plan with a shift to support in-district pay to ride first.
- F. 23-24 School Calendar Mr. Anderson will bring the board in April for the last day of school to be a full day on May 24 to reach the 1,080 hours required by law. Teachers would return May 28th and 29th to fulfill their contract. Classified staff will have an opportunity to make up for those days as well. More details will be

forthcoming.

- G. 24-25 School Calendar There is no current legislation to change the start date of August 23, the district is moving forward with that date for now.
- H. CCSD Retention Survey Dr. Eighmy discussed the CCSD retention survey results. There was 90% participation by teachers that took the survey.
